- b. Automatic Detection: If you use our premium features, Subtracker may automatically detect subscription-related transactions. We'll collect transaction data, merchant names, and payment dates.
- c. Browser Data: We may collect basic browser data, including browser type, version, and other related information to ensure compatibility.

## How We Use Your Information

We use the collected information for:

- Providing and enhancing Subtracker's features.
- Analyzing usage to improve our extension.
- Sending you reminders or alerts.
- Responding to customer support requests.

## Information Sharing & Disclosure

We do NOT sell, trade, or rent your personal information to third parties. We might share aggregated, anonymized data with partners or for research purposes. This aggregated data can't be linked back to individual users.

## Data Security
